SUBJECT: FINAL ACTION ORDER REVOKING LICENSE NUMBER 24-32159-01

On November 16, 2017, an Order Revoking License was issued to Schulz Surveying & Engineering, Inc., for nonpayment of fee for License Number 24-32159-01, Invoice Number LFB 17-2663. Since 20 days have elapsed, action on the Order is as indicated below:

- ☐ License revoked for nonpayment of fee effective. All requirements of the Order are effective and should be confirmed. The Accounts Receivable Branch has entered Status of "Revoked" in the Web-Based Licensing System to indicate the license is revoked for nonpayment of fees. Future applications from the licensee should not be processed until all debts are resolved. The debt will be referred to the Department of the Treasury for collection. Regions should change the primary program code to the appropriate possession program code, and the old code should become the secondary code. Also, change the flag for "storage only" to n/a.

- ☐ Licensee submitted "Good Cause," therefore, the Order Revoking License is not in effect. Future applications from the licensee, however, should not be processed until all debts are resolved.
