This refers to your license amendment request dated September 12, 2017. Please find enclosed Amendment No. 95 removing Dr. Sara O'Connell and Dr. Leonard A. Copertino as authorized users. This amendment also authorizes Dr. David Brill, Dr. Pradnya Prakash-Velankar, and Dr. Roshanak Bagheri as authorized users for materials authorized by 10 CFR 35.200. We did not authorize Dr. Brian Christopher Cambi at this time as the documentation submitted did not sufficiently demonstrate training and experience. You may request to amend the license and submit the required information at a later date without prejudice.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
