MEMORANDUM AND ORDER
(Granting Joint Unopposed Motion to Retain
Current Monthly Disclosure Update Schedule)

The Licensing Board's June 14, 2013 initial prehearing order requires that, in the absence of some other agreement among the parties to this proceeding, issuance of the earlier of the NRC staff's final National Environmental Policy Act-related environmental document or Atomic Energy Act-associated Safety Evaluation Report (SER) would change the period for mandatory document disclosure updates from monthly to bi-weekly. See Licensing Board Memorandum and Order (Initial Prehearing Conference and Scheduling Order) (June 14, 2013) at 6 (unpublished). In a January 25, 2018 joint motion, the parties to this proceeding request that this provision of the Board's initial prehearing order not be implemented so that the current requirement for monthly mandatory document disclosure updates will remain operative.* See

* This motion apparently was filed in anticipation of the late January issuance of the staff's final SER relative to the Marsland Expansion Area. See Licensing Board Memorandum and Order (Revised General Schedule) (Apr. 20, 2017) at 2 (unpublished).

Joint Unopposed Motion to Retain Current Monthly Disclosure Update Schedule (Jan. 25, 2018)
at 1-2.

The motion, being jointly filed and unopposed, is granted in that the current disclosure update schedule, under which the parties submit updates to their mandatory disclosures on the first day of each month, shall remain in effect; provided, however, that for any month in which the first day falls on a weekend or federal holiday, the submission can be filed on the next federal business day. See 10 C.F.R. § 2.306(a).
