INVESTIGATIVE SYNOPSIS

This investigation was initiated on August 31, 2016 by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI), Region II (RII), to determine whether a former quality control inspector employed by Duke Energy at H.B. Robinson Steam Electric Plant, Unit 2, Hartsville, SC, was discriminated against for raising safety concerns.

Based on the evidence developed during this investigation, the allegation that a former quality control inspector was the subject of discrimination for raising safety concerns was not substantiated.
