By letter dated October 3, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17331A484), Duke Energy Progress LLC (the licensee) submitted a license amendment request (LAR) for Brunswick Steam Electric Plant (BSEP), Units 1 and 2. The proposed LAR would revise Surveillance Requirement (SR) 3.8.4.5 contained in TS 3.8.4, "DC Sources - Operating." Specifically, the TS change proposes to amend the required supplied amperage of the battery chargers contained within SR 3.8.4.5.

The purpose of this email is to provide the results of the NRC staff's acceptance review. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the staff to complete its detailed technical review. The acceptance review is also intended to identify whether the LAR has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

The NRC staff has reviewed the LAR and concluded that it provides technical information in sufficient detail to enable the NRC staff to complete its detailed technical review and make an assessment regarding the acceptability of the proposed request. However, NRC staff's determination does not preclude the request for additional information as the review proceeds. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the staff's ability to complete the detailed technical review are identified despite the completion of the acceptance review.

The NRC staff estimates that this LAR will take approximately 160 hours to complete and that the review can be completed within the time period requested by the licensee. These estimates are based on the staff's initial review of the LAR and they could change due to several factors, including requests for additional information and unanticipated addition of scope to the review. If there are emergent complexities or challenges in the review that would cause changes to the initial forecasted completion dates or hours, the reasons for the changes, along with the new estimates, will be communicated to you.
