Pursuant to Section 50.55a (a) (2) (ii) of 10 C.F.R. Part 50, Niagara Mohawk Power Corporation requests authorization to invoke ASME Section III Code Case N-242 entitled "Materials Certification" on Nine Mile Point Unit 2. Although not currently listed in Regulatory Guide 1.85, the subject Code Case has been prepared and issued by ASME to resolve earlier misinterpretations relating to certification of code materials. The use of this Code Case was approved for the SNUPPS plants by Mr. Olan D. Parr of your staff in a letter dated July 13, 1979.

Niagara Mohawk needs to use this Code Case where applicable for the certification of materials purchased for Nine Mile Point Unit 2.
