## NRC Visit Information for Discussion

### Forecast Site Weather:

- Rain Sat/Sun prior to site visit
- Tuesday - highs expected in lower 40's and sunny
- Wednesday - highs expected in lower 50s and sunny

### Dress:

- dress in comfortable layered clothing for hiking
- sturdy boots for walking trails and elevated terrain, expected wet/muddy terrain
- consider carrying second pair of shoes/boots for trailer/return van trip
- gloves are recommended
- hard hats are not required

### Meals:

- Tuesday - scheduled lunch time 1100-1215 on Market Square next to the TVA Knoxville Office Complex. Suggest Blue Coast Grill, Subway, or Market House Café on the Square or the TVA café in the office complex. Can place pre-orders at Market House Café Tuesday morning and have ready when we break for lunch.
- Wednesday - will provide Subway sandwich trays, chip selection and Power-aid and bottle water on the CRN Site. Suggest \$5 donation for NRC.

### Building Access:

- Tuesday - Check-in at the Knoxville Office Complex West Tower first floor Visitors Desk between 0800 and 0830. Will need drivers license or pass port. Will pass thru metal detectors and bags will be x-rayed. TVA will have escorts back to the meeting room.
- Wednesday - Will check-in at the ORNL Visitors Center and meet ORNL escort. TSA accepted identification is required for ORNL.
