Enclosed is Amendment No. 101 to your NRC Material License No. 21-01333-01 in accordance with your request.

Please note that we have reformatted your license in our new Web Based Licensing (WBL) system. As a result, various conforming changes and updates to your license have been made so please review the enclosed document carefully and be sure that you understand all conditions.

If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

We deleted Condition No. 20 from your license, as it appeared on Amendment No. 100, in favor or referencing 10 CFR Part 71 in the Preamble at the top of page one of your license.

In Subitem No. 6.B., we did not continue the wording at the end of the authorization "except as specified below," as it did not seem necessary.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
