To Whom It May Concern:

On or about April 1, 2018 (the "Effective Date"), St. Luke's Des Peres Episcopal-Presbyterian Hospital intends to complete the purchase of substantially all of the assets of Des Peres Hospital (NRC License # 24-32195-01). We are providing the following information in order to receive written consent from the NRC for the transfer of control of NRC License # 24-32195-01, and the information provided follows the outline provided in NUREG-1556, Volume 9, Rev 2 and NUREG-1556, Volume 15.

1. As mentioned above, as of the Effective Date, St. Luke's Des Peres Episcopal-Presbyterian Hospital ("Transferee"), a subsidiary of St. Luke's Hospital, will be acquiring substantially all of the assets of Des Peres Hospital (the "Hospital"). The Hospital is currently owned by Des Peres Hospital, Inc. ("Transferor"). As of the Effective Date, Transferee will operate the Hospital under the name "St. Luke's Des Peres Hospital." The board of directors of Transferee will consist of Christine M. Candio, RN, FACHE; Scott H. Johnson; and Eugene M. Toombs. 2. Transferee does not intend to make any changes in personnel or duties that relate to the licensed program at the Effective Time of the transfer of control. Transferee also does not intend to make any changes in the training program at the Effective Time of transfer of control.


3. Transferee does not plan on making any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program at the Effective Time of transfer of control.
4. The status of the Transferor's facilities, equipment, and radiation safety program is current with respect to the license. There are no known contamination issues. At this time, all required surveillance (including calibrations, leak tests, area surveys, wipe tests, training, quality control and related records) has been performed, documented, and reviewed, including the results.
5. Not applicable
6. All records concerning the safe and effective decommissioning of the facility will be transferred to the Transferee as of the Effective Time. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
7. Both the Transferor and Transferee agree to transferring control of licensed material and activity as of the Effective Time. Other than as noted in this letter, there are no specific conditions on the transfer of the licensed material and activity, as the transfer is part of the sale of substantially all of the assets of the Hospital to Transferee, and Transferee will continue operations of the Hospital as of the Effective Time. At this time there are no open inspection items.
8. Transferee will abide by all constraints, conditions, requirements, representations, and commitments of the Transferor.
9. Transferee is not a fuel cycle facility so this item is not applicable.
