Corey –

The staff has the following follow-up question on SNC's February 1, 2018, RAI response for ALT-08 (ML18032A643).

In the response of RAI 5, the licensee states that the design specification will describe the weld joint in which any alternate counterbore configurations on weld joints are used. It is not clear to the staff that a fatigue evaluation that complies with ASME Subsection 3200 requirements will be performed for alternate counterbore configurations on these weld joints. The staff requests the licensee clarify whether a fatigue evaluation will be performed for alternate counterbore configurations on weld joints in accordance with ASME Subsection 3200.

As we discussed, I am checking to see whether the staff is available to discuss this topic at the public teleconference this Thursday morning, and you are checking the same on the SNC side.
