The purpose of this modification is to exercise Option Year Four and add funding in the amount of \$6,243.80, hereby changing the period of performance end date from 6/3/2018 to 6/3/2019 and increasing the total amount obligated from \$40,434.47 to \$46,678.27. Therefore, the contract is revised as follows:

1. Section B, Clause NRCB080 CONSIDERATION AND OBLIGATION – FIRM-FIXED PRICE is deleted in its entirety and replaced with the following:

“The total amount of the Firm-Fixed-Price portion of this contract is \$46,678.27, and this amount is fully-funded. There are five (5) remaining option years for annual maintenance of historical database and reporting trouble-shooting:

“This contract shall commence on September 29, 2014 and will expire on June 3, 2019. The term of this contract may be extended at the option of the Government for an additional five (5) option periods:

Option 2: from 6/4/2016 – 6/3/2017 **(Exercised)**
