SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-19037/2017-001 AND  
NOTICE OF VIOLATION

Dear Mr. Parker:

On January 16, 2018, the U.S. Nuclear Regulatory Commission (NRC) cited BJ Services, LLC for four violations involving the failures to: (1) conduct a physical inventory every six months; (2) test the proper operation of the on-off mechanism (shutter) at intervals not to exceed six months; (3) conduct a public dose assessment; and (4) prepare shipping papers in accordance with the requirements in Title 49 of the *Code of Federal Regulations* (CFR) Part 172 Subpart C. Inspection Report 030-19037/2017-001 with enclosed Notice of Violation required you to respond in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession ML17345A951). You responded by letter dated February 6, 2018.

After reviewing the information provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
