To Whom It May Concern:

This letter transmits changes in Wolf Creek Nuclear Operating Corporation's (WCNOG) updated list of Owners, Officers, Directors and Executive Personnel (OOOEP) for WCNOG and some of its owner companies in respect of the Nuclear Regulatory Commission's Foreign Ownership, Control or Influence (FOCI) determination and Facility Security Clearance determination for WCNOG and Wolf Creek Generating Station.

The reference transmitted separate, updated, confidential OOOEP lists for WCNOG and its three owner companies (Kansas Gas and Electric Company [KGE], Kansas City Power & Light Company [KCPL] and Kansas Electric Power Cooperative, Inc. 
WCNOC also wishes to advise the NRC of a recent non-significant change to information on certain individuals named in their OODEP list provided with the reference, as follows:
