Dear Commissioners and Staff:

Pursuant to 10 CFR 72.4, 10 CFR 72.44(e) as referenced by License Number SNM-2510, and 10 CFR 72.186(b), enclosed is a report of the changes to the Rancho Seco Independent Spent Fuel Storage Installation (ISFSI) Physical Protection Plan (PPP) (Amendment 8), including the incorporated Contingency Plan, and the Training and Qualification Plan (T&QP) (Revision 5), effective December 20, 2017. The changes did not decrease the effectiveness of the PPP or the T&QP. The changes meet the requirements of the physical protection plan and training and qualification plan as contained in License No. SNM-2510, amendment 4, Condition 12, effective November 24, 2017, as modified by the NRC Order dated October 16, 2002, containing the Interim Compensatory Measures for Physical Security and the NRC Order dated August 18, 2004 containing the Additional Security Measures for Access Authorization.

SMUD makes no regulatory commitments (as defined by NEI 99-04) in this letter.
