Dear Mr. Ho:

This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if the former president and radiation safety officer of JNB Enterprises (doing business as Jenbo USA) continued to distribute regulated lighting products containing Krypton-85 after Jenbo USA's NRC Exempt Distribution License was terminated. Based on the evidence developed during the OI investigation, the NRC could not substantiate that wrongdoing occurred.

Please note that the complete OI investigation report, including supporting documentation, may be obtained by you and the public under the Freedom of Information Act (FOIA), subject to redaction of information pursuant to the FOIA.
