Dear Ms. Stalnaker:

By letter dated November 3, 2017 (ML17319A426), Stonewall Jackson Memorial Hospital submitted to the U.S. Nuclear Regulatory Commission (NRC) a request for consent to an indirect license transfer of NRC Materials License No. 47-18080-01. Based on the information provided, the NRC understands that Monongalia Health System, Inc. (MHS) became the sole member of Stonewall Jackson Memorial Hospital Company, the full legal name for Stonewall Jackson Memorial Hospital. As such, control of Stonewall Jackson Memorial Hospital was indirectly transferred to MHS, its new parent company. We further understand that this transfer will not result in any changes to the licensee name, licensed materials, persons using the licensed material, location of use, or persons responsible for the radiation safety program. Please note that the name on the license will be changed from Stonewall Jackson Memorial Hospital to Stonewall Jackson Memorial Hospital Company to reflect the full legal name, but we understand this has always been the legal name and is not a result of the transfer.

Based on the above understandings, as more fully detailed in the enclosed Safety Evaluation Report, which documents the NRC staff's review of the request, and in accordance with 10 CFR 30.34, the NRC approves the proposed transfer. An environmental assessment for this action has not been prepared by the NRC, because this action is categorically excluded under 10 CFR 51.22(c)(21). Please find Amendment No. 23 changing the licensee name to Stonewall Jackson Memorial Hospital Company. We understand that the transaction occurred on October 1, 2017, but the license and the materials subject to the license were specifically excluded. That portion of the transaction will occur immediately following the NRC's written consent to the license transfer. Please note that you will need to notify us promptly, in writing, after the license transaction has been finalized and include a signed copy of the agreement confirming completion of the transaction. If this planned transaction has not been consummated within 30 days of the date of this letter, please notify us in writing. Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions of the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

Future changes in the licensee's name, licensed use, licensed materials, licensed location, or persons responsible for licensed material require submission of a request to amend the license. NRC approval must be received prior to implementation of the proposed change.


