### DESCRIPTION OF MATERIAL(S) OR FACILITY(IES)

This license is amended to: 1) change the name of Uranerz Energy Corporation to Energy Fuels/Nichols Ranch," as listed under "Other U.S. Party(ies) to Export"; and 2) extend the expiration date from December 31, 2017, to December 31, 2022.

The licensee is authorized to export a cumulative total of 12,000,000 kilograms natural uranium in the form of uranium ore concentrate (U<sub>3</sub>O<sub>8</sub>). The uranium authorized for export is to be returned to the United States. Canada must obtain U.S. prior approval before the material is re-transferred.

Conditions 3, 6 and 7 on page 2 apply.

Neither this license nor any right under this license shall be assigned or otherwise transferred in violation of the provisions of the Atomic Energy Act of 1954, as amended, and the Energy Reorganization Act of 1974.
