Please find enclosed Amendment Number 11 to NRC License Number 53-27731-01 approving the conducting of radiography outside of your field station address specified in Condition 10(i)(B), as requested. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(vi). You should review this license carefully and be sure that you understand all conditions. You can contact me at 817-200-1590 if you have any questions about this license.

Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
