Dear Ms. Jenny:

By letter dated October 30, 2017 (GLE-2017-0047) entitled, "Submittal of Brady Integrated Security Inc. Non-Possessing Facility Clearance Paperwork (for reinstatement)," Agencywide Documents Access and Management System (ADAMS) Accession Number ML17325B009, Global Laser Enrichment requested a non-possessing facility clearance (FCL) for Brady Integrated Security Inc. The U.S. Nuclear Regulatory Commission (NRC) staff in consultation with the U.S. Department of Energy has reviewed the FCL request. This review identified a number of sections that need clarification.

The attached enclosure provides requests for additional information (RAI) that are needed for the NRC to complete its review. This information should be provided to the NRC within 30 days from the date of this letter.

Subject to receipt of sufficient information in your RAI response, we anticipate completing our review by the end of April 2018. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
