SUBJECT: GEOCONCEPTS ENGINEERING, INC., CONSENT TO TRANSFER LICENSE  
AND LICENSE AMENDMENT, MAIL CONTROL NO. 601862

Dear Mr. Maier:

By letter dated November 20, 2017, Agencywide Documents Access and Management System (ADAMS) Accession No. ML18003A281, you notified the U.S. Nuclear Regulatory Commission (NRC) of a direct transfer of control of GeoConcepts Engineering, Inc.'s NRC License, No. 45-25467-01 to Terracon Consultants, Inc. Your letter dated November 20, 2017, stated that the transfer of ownership occurred on October 31, 2017. Thus, this was a post-hoc notification of a direct transfer of control of a NRC licensee. Terracon Consultants, Inc. and GeoConcepts Engineering, Inc. did not comply with NRC regulations as they did not receive the NRC's prior written approval for this transfer of control as required by 10 CFR 30.34(b) and Section 184 of the Atomic Energy Act of 1954, as amended.

From the above letter, we understand that this transfer did not result in a change associated with the materials, persons using licensed material, or persons responsible for radiation safety at the licensed facility, the locations, facilities, and equipment, nor the radiation safety program. We also understand from the letters that the name of the licensee will be changed to GeoConcepts Engineering, Inc., a Terracon Company.

Based on the above understandings, as more fully detailed in the enclosed NRC staff's Safety Evaluation Report, which documents the NRC staff's safety review of the notification, the NRC consents to the transfer. Please find enclosed Amendment No. 8 authorizing a name change to GeoConcepts Engineering, Inc., a Terracon Company.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(21).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. 
