The purposes of this modification are to: 1) increase the current ceiling by \$2,000,000.00, from \$12,244,663.51 to \$14,244,663.51, decrease OPTION YEAR 6 ceiling by \$1,114,026.43 from \$1,114,026.43 to \$0.00, and decrease OPTION YEAR 5 by \$885,973.57 from \$1,780,094.71 to \$894,121.14 to accommodate and allow for additional ADAMS support while the NRC transitions this task order to GLINDA (The net result is a \$0.00 increase in the Value of this task order); and 2) obligate funds in the amount of \$104,250.00, thereby increasing the total obligated amount from \$12,244,663.51 to \$12,348,913.51.
