The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2017-001) on October 5, 2016, to determine whether an engineer was discriminated against for raising safety concerns at Nine Mile. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the engineer was discriminated against for raising safety concerns.
