Dear Mr. Sullivan:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2016-009) on February 4, 2016, to determine whether a former engineer at James A. FitzPatrick Nuclear Power Station deliberately subverted a fitness for duty (FFD) test and provided a false statement regarding the test. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the engineer subverted a FFD test and/or provided a false statement.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
