<u>Recommendation 3:</u>	Address the identified vulnerabilities within the timeframes specified in ISD [Information Security Directorate] standard ISD-STD-0020, <i>Organization Defined Values for System Security Controls</i> .
Agency Response Dated February 2, 2018 and February 27, 2018:	<p>Region IV has completed the remediation for the identified high risk. The completion date for the remediation/deviation of moderate risk findings is now scheduled for completion by March 2, 2018.</p> <p>Please see attached spreadsheet showing the remediation status of all Critical and Moderate (Area of Concern) findings, which were discovered during the 2017 FISMA Evaluation. All "Critical" and "Areas of Concern" findings have been remediated. This should closeout item #3 of the FISMA Report.</p>
OIG Analysis:	OIG received a spreadsheet detailing the vulnerabilities and determined that the vulnerabilities were addressed within the timeframes specified in ISD standard ISD-STD-0020. The high risk and moderate risk findings are now completed. This recommendation is therefore considered closed.
