This refers to your license amendment request dated November 28, 2017. Please find enclosed Amendment No. 24 naming Joy A. Johnson, M.D., as Radiation Safety Officer, removing authorization for 10 CFR 35.400 and 600 materials, and removing all Authorized Medical Physicists from the license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
