The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2015-021) on June 19, 2015, to determine whether an Assistant Radiation Safety Officer (ARSO) falsified inventory records at the Naval Surface Warfare Center (NSWC), Crane, IN. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that an ARSO falsified inventory records at the NSWC, Crane, IN.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.
