In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting revisions 17 and 18 to the Dresden Station Security Plan. Both revisions were implemented on January 5, 2018. In accordance with 10 CFR 50.54(p)(2), EGC is submitting these changes within 60-days of implementation.

Revision 17 was implemented to address references to Starcom® radios. Revision 18 was implemented to remove redundancy in Section 11.1 and to update Figure 1 of the Dresden Station Site Security Plan.

Attachments 1, 2, 3, and 4 contain SAFEGUARDS INFORMATION. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (d)(1), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).
