Mr. Chaisson,

I'm sending you this email documenting our telephone conversation yesterday. You told me that you were living in Morgan City, Louisiana for the foreseeable future (indefinitely). You stated that you were looking for a job and talked with Engineering and were going to talk with Global X-ray soon. You have been without a job for over a year.

We discussed possible dates for a face-to-face meeting in accordance with Condition 1(a)(i) of the Order. Tentatively, we talked about meeting in early February and the NRC staff could meet you in New Orleans (about 1 ½ hour drive for you). I told you I would work on setting it up and would be back in touch with you.

Next, I pointed out that we had not received an email about your quarterly activities (the Order requires that once per quarter, you must email NRC RIV via email ([EA-14-222@nrc.gov](mailto:EA-14-222@nrc.gov)) regarding engagement in NRC-licensed activities and a brief summary of these activities). You stated that you thought you needed to send the email only if you had been working in NRC jurisdiction. I told you that you needed to send us the information quarterly whether you worked in NRC jurisdiction or not.

As a reminder - your email must include a brief summary of the activities conducted in NRC's jurisdiction. This summary must include an overview of activities completed within the previous quarter and identification of known or intended work projections

and locations for next quarter. The last quarter ended on December 31, 2015, and as of this email we have not received your email.

You told me that you would provide your written summary for last quarter and next quarter. Again, please send your email to [EA-14-122@nrc.gov](mailto:EA-14-122@nrc.gov) or you can "reply-to-all" on this email.

Please be aware that there are other requirements related to working for an NRC licensee or an agreement state licensee who works in the NRC's jurisdiction under reciprocity. Before starting work for a licensee, please refer to condition 2 of the Order to remember the timelines for other notifications to the NRC and the licensee.

Mr. Chaisson,

I received your email. There is one error – you and I spoke on 1/20/2016, not 4/20/16, as you indicated below.
