By letter dated March 6, 2018 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML18010A087), the U.S. Nuclear Regulatory Commission (NRC) issued Amendment No. 297 to Renewed Facility Operating License No. DPR-40 for the Fort Calhoun Station, Unit 1. The amendment consisted of changes to the renewed facility operating license and the Technical Specifications (TSs) in response to your application dated March 31, 2017, as supplemented by letter dated September 26, 2017.

The NRC staff recently discovered typographic errors had been introduced on page 1 of the Attachment to Enclosure 1 of Amendment No. 297. These errors resulted in inaccurate page number ranges in the "REMOVE" column for the license and TS Sections 2.8, 2.13, and 3.2. Accordingly, we are enclosing a corrected page 1 of the Attachment for Amendment No. 297. The corrected page contains marginal lines indicating the corrected areas. Please replace this page in your copy of the license amendment.


These corrections are administrative in nature and do not change the NRC staff's conclusions regarding Amendment No. 297 for Fort Calhoun Station, Unit 1.
