This is to acknowledge receipt of your electronic correspondence to the U.S. Nuclear Regulatory Commission (NRC) dated February 22 and March 1, 2018, which included a large number of attachments as well as a video. Thank you for putting your request in writing so that we can ensure that there are no misunderstandings. Your two emails have been added to ADAMS¹ as public records. In general, over the last four years, we have placed all your incoming and outgoing correspondence in ADAMS to ensure it is publicly available.
