4. Missing nuclear test reports
5. Missing dosimetry reports
6. Missing radioactive waste disposal records and/or logs

7. Unavailability of Patient Dose Log Book for review and/or not current
8. Inadequate quality control and records
9. Inadequate Preventative Maintenance records
10. Lack of ancillary staff training on Radiation Safety
11. Dosimetry badges not secured
12. Lack of supply inventory
13. Alleged violation of the Safe Use of Radiopharmaceuticals
14. Survey meter not being used
15. Occupational Worker Exposure Letters not completed in 2016
16. Failure to perform Annual Approval of Clinical Protocols
