Category: This is a Category 1 meeting. The public is invited to observe this meeting and will have one or more opportunities to communicate with the NRC after the business portion of the meeting but before the meeting is adjourned.

Purpose: The purpose of this teleconference is to discuss Dominion Energy Nuclear Connecticut, Inc.'s (DENC; the licensee), planned relief request for Millstone Power Station, Unit No. 3 (MPS3), related to the MPS3 "C" Charging Pump. The licensee proposes to eliminate the quarterly Group A test on the "C" Charging pump for the time periods when the "C" Charging pump is not required to be credited to support continued plant operation. A pump comprehensive test will continue to be performed on a refueling outage frequency. If it becomes necessary to place the "C" Charging pump into service, a quarterly test will be performed prior to declaring the pump operable. The licensee will discuss the scope and proposed schedule associated with the MPS3 submittal.
