The purpose of this letter is to formally request review and approval for Grand Gulf Nuclear Station's long-term steam dryer inspection plan along with the baseline inspection results, in order to satisfy License Condition 2.C(46)(g):

*At the end of the second refueling outage following the implementation of the EPU, the licensee shall submit a long-term steam dryer inspection plan based on industry operating experience along with the baseline inspection results for NRC review and approval.*

The baseline inspection results were previously submitted via Reference 1. The inspection plan is specified in paragraphs 2.6.1 and 2.6.2 of the GEH Proprietary document 000-0125-6316-R2-P "Grand Gulf Nuclear Station (GGNS) Recommendations for Future Inspection – Replacement Steam Dryer" that was submitted to the NRC via Reference 2.
