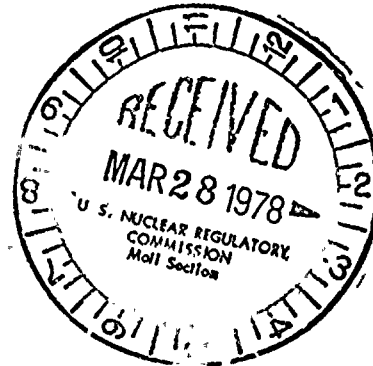

The purpose of this submittal is to support Cycle 2 operation of St. Lucie Unit 1. Associated Technical Specification changes are described in Section 9 of the Reload Safety Evaluation (RSE) and shown on the attached Technical Specification pages bearing the date of this letter in the lower right hand corner.

By letter dated February 2, 1978 (L-78-39), Florida Power & Light Company submitted proposed technical specifications pertaining to a clarification of the relationship between reactor trip system response time and Resistance Temperature Detector (RTD) response time as applied to Technical Specification 4.3.1.1.3. The letter indicated that the evaluation was applicable to Cycle 1A and would be reverified for Cycle 2 as part of the Reload Safety Evaluation. The applicability of the proposed change to Cycle 2 has been confirmed by the NSSS vendor.
