

In reviewing the requested technical specification amendment which was submitted to you on March 10, 1978 (L-78-87), it was noted by our staff that a snubber had been inadvertently omitted from deletion from Table 3.7-2. On page 3/4 7-36, FPL Location Number 113 should have been deleted. This hydraulic snubber will be replaced by a 3 kip mechanical snubber during the present refueling outage.

It is requested that our submittal of March 10 be amended by including FPL Location No. 113 among those to be deleted.
