Dear Mr. Dallimore:

This letter is in regard to your letter dated March 16, 2018, requesting to authorize the distribution of the stabilization modules as stand-alone unit under Title 10 of the *Code of Federal Regulations* (10 CFR) 32.14 to your Exempt Distribution License No. 20-35393-01E. After reviewing your amendment request, the U.S. Nuclear Regulatory Commission (NRC) staff concluded that the module could not be authorized under 10 CFR 32.14 and 10 CFR 30.15(a)(9). During our telephone conversations, we explained to you the reason why the requested item cannot be covered under 10 CFR 30.15(a)(9), and that we will suspend the amendment request at this time. I also informed you that we will work with our General Counsel's office to determine which regulation may cover this item, and communicate this decision to you.

This action is taken without prejudice to submission of the requested information.
