Kate,

Here is some background for the submittals made by NINA in response to the NRO for ABWR-related RAIs. When NINA put together their transmittal packages for RAI responses, they typically marked RAIs that had proprietary content as "Westinghouse Proprietary Class 2" for the version including the proprietary content and "Westinghouse Non-Proprietary Class 3" for the version with the proprietary content redacted. For RAIs that had no proprietary content, NINA did not include any proprietary marking. So, RAI responses that are non-proprietary would have either a Non-Proprietary Class 3 marking or no marking at all. This is consistent with their attachments, as well as the listing of RAIs in the transmittal letters.

Since I found two attachments that were incorrectly marked, I have provided specific responses for each of the transmittals that you list below.

I am processing WCAP-17203-P draft SE for concurrence and noticed few problems with NRO-processed/reviewed following referenced STP/NINA/Westinghouse submittals.

I need you to review the letters below and confirm that everything in those letters is non-prop (some of the RAI responses listed within it are not properly marked – they seem to be non-prop, but it is not clear from the cover letters).

ML110840711 - Attachment 1 RAI-6 – is not properly marked as Non-Prop or Prop. It appears to be non-prop (there are no prop markings) as described in the cover letter. Please confirm.

Attachment 1, RAI-6 is Non-Proprietary.

ML11166A048 - Attachment 11 RAI-29 S01 – is not properly marked as Non-Prop or Prop as described in the cover letter. It appears to be non-prop (there are no prop markings). Please confirm.

Attachment 11, RAI-29 S01 is Non-Proprietary.

ML110550637 – Attachments 1-4, 6, 8, 9-13 – are not properly marked as Non-Prop or

Prop. They appear to be non-prop (there are no prop markings) as described in the cover letter and the letter states: *"Attachments 1 through 11 contain the responses to the above RAI questions. Attachments 12 and 13 contain the non-proprietary versions of the two proprietary responses. Attachment 14 contains the request for withholding of proprietary information, the affidavit, the proprietary information notice, and the copyright notice."*

Please confirm.

Attachments 1-4, 6, 8, and 9-13 are all Non-Proprietary. Note that Attachment 12 was improperly marked. It should have been: "Westinghouse Non-Proprietary Class 3" instead of "Westinghouse Proprietary Class 3." Also, Attachment 13 was incorrectly marked, and should have been: "Westinghouse Non-Proprietary Class 3" instead of "Westinghouse Proprietary Class 2."

ML11318A019 - Attachments 1-3, 5, 8, 9, 13, 17 – are not properly marked as Non-Prop or Prop. They appear to be non-prop (there are no prop markings) as described in the cover letter and the letter states: *"Attachments 1 through 17 contain the responses to the above RAI questions. Attachments 18 through 26 contain the non-proprietary versions of the proprietary responses. Attachment 27 contains the request for withholding of proprietary information, the affidavit, the proprietary information notice, and the copyright notice."*

Please confirm.

Attachments 1-3, 5, 8, 9, 13, and 17 are all Non-Proprietary.

ML11152A187 - Attachments 1-3, 7 – are not properly marked as Non-Prop or Prop. They appear to be non-prop (there are no prop markings) as described in the cover letter and the letter states: *"Attachments 1 through 17 contain the responses to the above RAI questions. Attachments 18 through 30 contain the non-proprietary versions of the thirteen proprietary responses. Attachment 31 contains the request for withholding of proprietary information, the affidavit, the proprietary information notice, and the copyright notice."* Please confirm.

Attachments 1-3 and 7 are Non-Proprietary.

ML11361A387 – Attachments 1 and 4 - are not properly marked as Non-Prop or Prop. They appear to be non-prop (there are no prop markings) as described in the cover letter and the letter states: *"Attachments 1, 2, 3, 4 and 5 contain the responses to the RAI questions. Attachments 6, 7, and 8 contain the non-proprietary versions of the three proprietary responses. Attachment 9 contains the request for withholding of proprietary information, the affidavit, the proprietary information notice, and the copyright notice."*

Please confirm.

Attachments 1 and 4 are Non-Proprietary.

ML12159A017 – Attachment 5 RAI 25 S1 - is not properly marked as Non-Prop or Prop. It appears to be non-prop (there are no prop markings) as described in the cover letter and the letter states: *"Attachments 1 through 6 contain the responses to the RAI questions. Attachments 7 through 11 contain the non-proprietary versions of the proprietary responses. Attachment 12 contains the request for withholding of proprietary information, the affidavit, the proprietary information notice, and the copyright notice."* Please confirm.

Attachment 5, RAI-25 S1 is Non-Proprietary.
