One item which needs attention is the Enclosure 1 of M180105/SPM 18-032, SF 328 Certifications for GNF-A and GNF-H/GNF. It states the enclosure contains a completed Standard Form 328 for each site but this is incorrect -- there are no signed/dated SF 328 forms for the GNF entities.
