


Dear Mr. Giambusso:

As the detailed design and construction planning for the Palo Verde Nuclear Generating Station, Units 1, 2, and 3 has proceeded, we have found that a significantly longer period of time than initially anticipated will be required to construct these facilities. Therefore, based on a prospective decision date for receipt of a construction permit of May 10, 1976 (as indicated in NRC (AEC) letter, dated November 11, 1974), we have changed the presently scheduled Commercial Operation dates as follows:


