To summarize, you were informed that the Petition Review Board (PRB) for your 2.206 petition concerning the FirstEnergy Nuclear Facility Operations bankruptcy (ML18094A642), has made an initial recommendation to accept the requested actions in your petition for review under the NRC's 2.206 process. Also, you were asked whether you desired an opportunity to comment on this recommendation, in person or via teleconference, consistent with MD 8.11.
