Please see the attached invoice #LFB 18-4905 dated July 19, 2018 with a due date August 18, 2018 in the total amount of \$76,445.97. Consistent with our previous email below and letter dated May 24, 2018 (attached), we are requesting inclusion of these charges with this dispute and waiver request.
