The purpose of this letter is to reference revised Owner's Group (PWROG) Topical Reports that support the Turkey Point Subsequent License Renewal Application. Revision 0 of these reports were included in Reference 5. Subsequent to FPL's submittal, the PWROG provided a revision of the enclosed reports to ensure clarity of information. No new analysis was performed during the revision process for these documents.
