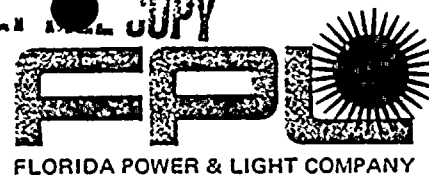

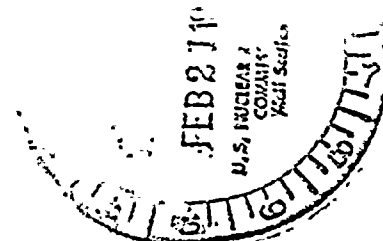

Major Safety-related maintenance performed during the month included the replacement of a failed gasket on the pressurizer manway closure head and the replacement of five (5) pressurizer manway closure head retaining studs.
