Dear Dr. Piefer:

By letter dated June 20, 2018, SHINE Medical Technologies, Inc. (SHINE) submitted to the U.S. Nuclear Regulatory Commission (NRC) presentation slides to support a June 28, 2018, public meeting related to the development of SHINE's operating license application for a medical radioisotope facility, including topics on instrumentation and control, material control and accounting of special nuclear material, and design changes. Subsequently, SHINE determined that the proprietary markings of the presentation slides required revision and resubmitted the presentation slides with appropriate sensitivity markings and redactions by letter dated July 2, 2018 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML18187A216).
