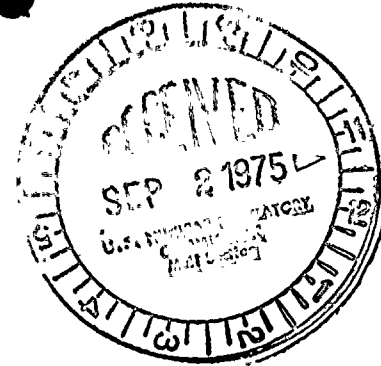

Dear Mr. Rusche:

Carolina Power & Light Company has recently finalized its schedule for submittal of additional information required by the NRC staff. This submitted information will result in completion of all safety-related issues. Schedules for providing "need for power" and "financial" information will be provided to the Staff in the near future.

Final Acceptance Criteria

The additional information requested in Mr. Walter Butler's letter of July 2, 1975 will be provided by September 16, 1975. The information will be consistent with that provided by other Westinghouse plants and with the Harris analysis previously supplied to the NRC staff on July 11, 1975.

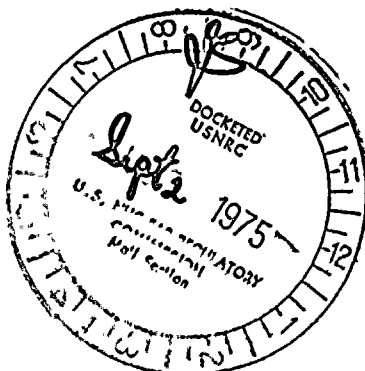
Loose Parts Monitoring System

A commitment to provide a loose parts monitoring system, as requested in Mr. Walter Butler's letter of July 3, 1975, will be made by September 16, 1975.

Regulatory Guides

Carolina Power & Light Company met with NRC representatives on August 26, 1975 to discuss those specific regulatory guide positions which have been identified by the NRC staff as currently unacceptable to them. During this meeting, CP&L responses to Mr. Walter Butler's letters of May 21, 1975 and May 29, 1975 were discussed. Resolved positions will be documented in the PSAR by September 22, 1975.

Regulatory Guides 1.88, 1.90, 1.91, 1.93, 1.94, 1.95, and 1.96 were addressed in our letter of August 14, 1975. Remaining technical positions on guides 1.89 and 1.92 will be submitted to you no later than September 22, 1975.



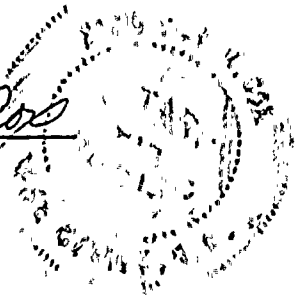

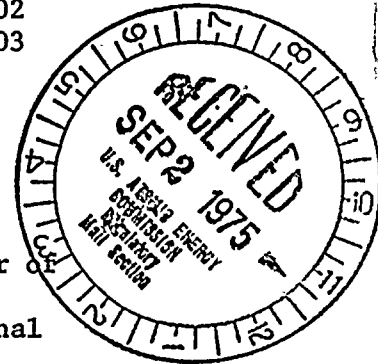
