In the referenced August 6, 2018, letter, Centrus Energy Corp. (Centrus) requested U.S. Nuclear Regulatory Commission authorization to resume classified cyber operations identified in Information System Security Plan (ISSP) *Centrus Energy Corp. Headquarters Classified Administrative Thin Client System Security Control Security Plan*, SP-HQ-0008, Revision 0. Also, in support of this request, Centrus provided the *Centrus Energy Corp. Headquarters Classified Administrative Thin Client System Security Assessment Report (SAR)*, SP-HQ-0009, Revision 0, on August 10, 2018.

The Department of Energy Nuclear Energy Oak Ridge Site Office, acting as the Authorizing Official (AO) for Centrus classified cyber networks, approves SP-HQ-0008, Revision 0, and SP-HQ-0009, Revision 0. Based upon these approvals, Centrus is authorized to operate (ATO) the network identified in this ISSP for the processing up to, and including, Secret Restricted Data for three (3) years from the date of this letter. To maintain this ATO, the continuous monitoring report must be submitted to the AO at least annually.
