This refers to your license amendment request dated August 14, 2018. Please find enclosed Amendment No. 11 authorizing the new location of use. We could not remove the current location of use, as your material currently resides in this location. After you move your material, please submit an amendment to remove the location Reparto Landrau at A-5 Amur St., San Juan, Puerto Rico.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
