On August 10, 2018 (NRC-2018-000711) and August 17, 2018 (NRC-2018-000722), our office sent to your office a Form 509, Statement of Estimated Fees for FOIA Requests, in each of your requests. In our emails transmitting the Form 509, and on the form itself, we informed you that, based upon the estimates received by the multiple program offices expected to have responsive records, the estimated fees for each request exceeded the \$250.00 floor at which requesters must submit an advanced payment.
