Dear Ms. King:

This letter refers to your license amendment request dated July 31, 2018 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML18249A004). In reviewing your application, we have determined additional information is required to complete our review. In order to continue our review, please address the issue listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) 32.18, 10 CFR 32.21, and 10 CFR 30.33.

In order to change your license name on your Exempt Distribution License 10-23980-01E, you need to provide a copy of your possession license issued by the State of Georgia to reflect your new name.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the U.S. Nuclear Regulatory Commission (NRC) may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
