Dear Mr. Holtz:

This refers to your license amendment request dated July 10, 2018. Please find enclosed Amendment No. 74 authorizing a new area of use to support the relocation of your nuclear medicine department. Please note that prior approval must be obtained from NRC to release areas for unrestricted use. In your letter dated August 27, 2018, you informed us that you do not wish to add the Cobalt-57 (Intrinsic Point Source; Model PHI-0124) and the Gadolinium-153 (Attenuation Source; Model HEGL-0133) sealed sources requested in the letter dated July 10, 2018. Please note, per your request in the August 27, 2018 letter, the Cobalt-57 and Gadolinium-153 sources have not been added to your license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
